**TERMS AND CONDITIONS**

**AIR TRAVEL IS NOT INCLUDED**

- Patrons are required to make their own reservations for their airfare. Most Patrons prefer this because of travel miles and rewards, flying from different cities in and out of Rome, and arriving or departing Rome different than the days of this trip.
- Patron must provide flight information once flights are purchased to Sue@Lohsen.com.

**ALSO NOT INCLUDED:**

- Health, trip cancellation/interruption, or baggage insurance.  
**ALL ARE STRONGLY RECOMMENDED, SINCE THERE ARE NO REFUNDS.**  
Please choose and purchase your own insurance.
- Meals not specified on the itinerary, items of a personal nature (hotel extras, laundry, phone calls, etc.).
- Airport shuttles and ground transportation not listed on itinerary.
- Deviations from the scheduled itinerary are at the expense of the individual Patron.

**COSTS ARE SUBJECT TO CHANGE**

- All costs are based on hotel contracts, transportation contracts, estimated costs from the Vatican office, estimated costs from restaurants, and previous trips and are subject to minor adjustments. Costs are based on a minimum of 18 Patrons attending. All costs are expressed in US Dollars converted from Euros at the highest exchange rate (1.19) over the past six months. Currency exchange rates are subject to change without notice and affect pricing.

**CANCELLATION POLICY**

- The \$500 per person trip reservation fee is non-refundable. You may cancel before February 10<sup>th</sup>. After that, when your final payment is due, there are no refunds. Trip cancellation insurance is recommended.

**UNUSED SERVICES**

- There is no right to a refund for any unused services.

**PASSPORT REQUIREMENT**

- A valid U.S. Passport is required.
- **ALL PASSPORTS MUST NOT EXPIRE SOONER THAN OCTOBER 2026.** If your Passport is set to expire sooner than October 2026, you must apply for new Passport to attend this trip.
- A copy of your Passport's inside page showing name and photo must be provided to the PAVM DC Chapter at the time of reservation to be shared with the Vatican Museum Patrons Office.

**HEALTH**

- All Patrons must be in good health and fully able to participate in all trip activities. There are long touring days and extensive walking over uneven surfaces, stair climbing that is not handicap accessible, and climbing into various conveyances. All Patrons must ensure that they are medically and physically fit for travel and that such traveling will not endanger themselves or others. Any Patron who is physically challenged must submit a letter from one's medical doctor stating capability to participate in this trip without assistance. Any special medical conditions or equipment must be advised in writing (including severe allergies) for evaluation of feasibility at the time of reservation. Should any special assistance be required, traveler agrees to bring a companion capable and willing to assist.

**STATE DEPARTMENT & OTHER AGENCIES**

- From time to time the State Department ([www.state.gov](http://www.state.gov)) and the Center for Disease Control ([www.cdc.gov](http://www.cdc.gov)) and other government agencies and departments issue travel advisories or warnings. PAVM DC Chapter cannot change the cancellation terms or conditions based on the issuance of any such warning or advisory or the occurrence of any terror, health, or other incident.
